In accordance with the California Government Code Section 82015, payments made at the behest* of elected officials are not considered contributions or gifts if they meet the following guidelines:

- payments are not made for legislative, governmental, or charitable purposes
- payments are not for purposes related to the official's candidacy for elected office
- payments are not used for the candidate's personal purposes

Although such payments are not gifts or contributions, they MUST BE REPORTED within 30 days after the total payments made by a single source equal to or exceeding \$5,000 in a calendar year.

Once the \$5,000 threshold is met, all subsequent payments by the same source during the calendar year must be disclosed within 30 days after the payment is made.


