

## Report of Payments Made at the Behest of an Elected Officer San Francisco Ethics Commission

(Govt. Code Section 82015(b)(2)(B)(iii)

In accordance with the California Government Code Section 82015, payments made at the behest of elected officials are presumed not to be contributions if they meet the following guidelines: payments are made principally for legislative, governmental, or charitable purposes payments are made principally for purposes unrelated to the official's candidacy for elected office payments are not made principally for the candidate's personal purposes

Although such payments are not contributions, they MUST BE REPORTED within 30 days after the total payments made by a single source equal to or exceed \$5,000 in a calendar year.

Once the \$5,000 threshold is met, all subsequent payments by the same source during the calendar year must be disclosed within 30 days after the payment is made.
