Re: Audit Selection of Year 2014 Campaign Committees and Lobbyists

This memorandum explains the Ethics Commission's audit selection guidelines and summarizes the levels of financial activity by the different types of committees and lobbyists that were active during 2014. At its March 23, 2015 meeting, the Commission will randomly select campaign committees and lobbyists to be audited.

- I. Selection of Campaign Committees for Audit Staff has determined that it will be able to audit <u>ten</u> recipient committees that were active in the June 3 and November 4, 2014 elections. The audit pool includes: ¹
- all candidates who ran for City elective office in the November 2014 election;
- ballot measure committees active in the June and November 2014 elections; and
- general purpose recipient and primarily formed candidate committees that were active in 2014.

¹ There were two publicly financed candidates in the November 2014 who are not part of the audit pool because they are already subject to a mandatory audit. The pool also excludes candidates for county central committees, general purpose committees that were selected for audit through the 2013 random selection process, and committees with financial activity of less than \$10,000.

² For candidates and ballot measure committees, the level of financial activity is based on the sum of expenditures made by these candidates and committees from the time their committees were formed through December 31, 2014. For general purpose committees, the level of financial activity is based on the expenditures made in 2014.

The November 2014 ballot involved the election of candidates for the offices of Assessor, Public Defender, the Board of Education, the Community College Board and the District 2, 4, 6, 8 and 10 seats of the Board of Supervisors. The June and November 2014 ballots included 15 ballot measures, which resulted in 22 ballot measure committees that were formed to support or oppose one or more of these measures. In total, the 2014 audit pool includes 60 committees that spent \$10,000 or more. Staff recommends that the Commission select ten, or 17 percent, of the 60 committees for audit in the following manner: six committees from activity level greater than \$100,000; two committees from activity level of \$10,000 to \$50,000.

On January 1, 2014, there were 40 pending campaign audits. In order to meet its goal of eliminating the backlog of audits, staff requested the Controller's office's assistance in conducting 13 of the 40 audits. These 13 audits are near completion. Work on the remaining 27 audits that were conducted by Commission staff has been performed, with fewer than five audits left to be released. Audit staff is working on preparing these and the 13 audits conducted by the Controller's office for release and has begun work on the audits of the two supervisorial candidates who received public funds in the November 2014 election. Staff's goal, beginning with the 2014 audit pool, is to complete all audits prior to the next year's audit selection. Given the work involved with releasing the unfinalized audits, staff's goal to conduct timely audits and the Commission's new mandate of conducting lobbyist audits, staff recommends that the Commission select ten campaign committees for audit from the 2014 audit pool (see attached list).

II. Selection of Lobbyist Audits

Effective July 26, 2014, section 2.135 of the San Francisco Campaign and Governmental Conduct Code requires the Commission to conduct randomly selected audits of one or more lobbyists. Staff recommends that the Commission select <u>four</u> lobbying firms that were active during the period covering July 26 through December 31, 2014. Given that lobbyists in the same firm may share reporting obligations, staff recommends that selection be based on lobbying firm/employer; staff will audit all lobbyists within any firm that is selected by the Commission. In determining the audit pool, weight was given to lobbyists with greater activity for which staff used a mix of the number of contacts and payments reported.

Lobbyists must report the number of contacts they make with officials and the amount of payments they receive from clients. It is possible for a lobbyist to make several contacts but report a low compensation amount or report a high compensation amount with few contacts. The audit pool consists of three levels of activity into which lobbyists are grouped based on the higher level of the payments or contacts reported during July 26 through December 31 (see attached list).

Table II below shows the number of lobbyists in each level of activity according to the higher of payments or contacts reported. As shown below, staff recommends that the Commission select four, or 11 percent, of 37 lobbyist firms in the following manner: two from activity level greater than \$100,000 or 100 contacts; one from activity level of greater than \$50,000 to \$100,000 or 50 to 100 contacts; and one from activity level of \$10,000 to \$50,000 or 10 to 50 contacts.
