Attached is a further revision of this ordinance (dated March 8, 2012), following last minute negotiations at the Board of Supervisors. It reverses the changes made at the February 28 Board meeting, except for these two items:

- 1. Section 1.138(b)(1) [page 3, lines 18-21]: the cap on the election campaign fund remains at \$7 million instead of \$13.5 million.
- 2. Section 1.140(c)(4) [page 8, lines 8-10], section 1.143(a) [page 9, lines 8-13]: the initial individual expenditure ceiling for mayoral candidates remains at \$1.475 million.

There is also a further conforming change required. Section 1.154(b)(1) [page 18, lines 5-14] addresses when Ethics must notify the Board and the Mayor that the public funds available prior to a mayoral election is too low. Previously, this level was set at \$8 per resident plus 15% - which equals approximately \$7.36 million. Given that the cap on the fund is only \$7 million, this needed to be lowered to \$7.50 per resident plus 15% - which equals approximately \$6.9 million. This technical language is also included in the attached proposal.

3	Ordinance amending the Campaign and Governmental Conduct Code and the

Municipal Elections Code to modify <u>funding of expenditure ceilings for the City's public</u> financing program, <u>to increase expenditure ceilings for supervisorial candidates</u>, to delay the date on which public funds may be disbursed, to change the qualification requirements for participating candidates, and to advance the date by which all local candidates must file their nomination papers.

NOTE: Additions are <u>single-underline italics Times New Roman</u>; deletions are <u>strike-through italics Times New Roman</u>.

Board amendment additions are <u>double underlined</u>.

Board amendment deletions are <u>strikethrough normal</u>.

Be it ordained by the People of the City and County of San Francisco: Section 1. Findings.

- 1. One of the primary purposes of the City's public financing program is to combat corruption and the appearance of corruption in local politics. By decreasing candidates' reliance on private campaign contributions, the City's public financing program reduces the possibility that contributions will allow private, relatively wealthy individuals to receive disproportionate access to City decision-makers or exercise undue influence with City elected officials. Lessening the need for private fund-raising also increases public confidence that City elected officials will act solely in the City's best interests.
- 2. The City's public financing program, by decreasing pressures to fund-raise from private, relatively wealthy sources, also encourages candidates to address the needs and concerns of a socio-economically broader group of San Francisco residents. It also allows candidates, during their election efforts, to engage City residents on local issues instead of focusing on fund-raising. These effects fulfill the fundamental purposes of democratic

government and decrease the public perception of corruption among elected	officials.	For
incumbents, decreasing the need to fund-raise also increases the amount of	time that	they
that can spend on governing instead of fund-raising.		

- 3. The independent expenditure ceilings employed by the City's public financing program are the sole means by which the City can attract viable candidates to participate. Viable candidates will only participate in a public financing program if it-the program ensures that participating candidates will not be easily outspent by non-participating candidates or third-parties. Without adjustable expenditure ceilings, candidates would not participate in the program, and low participation rates would render the program ineffective.
- 4. Since its inception in November 2000, the City's public financing program has been a success. For the past decade, many candidates seeking election to either the office of Mayor or the Board of Supervisors have participated in the City's public financing program.
- Section 2. The San Francisco Campaign and Governmental Conduct Code is hereby amended by amending Sections <u>1.138</u>, 1.140, 1.143, 1.144, <u>1.154</u>, and 1.170 to read as follows:
- SEC. 1.138. ELECTION CAMPAIGN FUND; APPROPRIATION OF FUNDS.

 <u>APPROPRIATION OF FUNDS</u>.
- (a) ESTABLISHMENT OF ELECTION CAMPAIGN FUND. There is hereby established a special fund of the City and County of San Francisco called the Election Campaign Fund. All money deposited in the Fund is hereby appropriated for use as specified in this Chapter and the implementing regulations.
- (b) APPROPRIATION TO ELECTION CAMPAIGN FUND. Except as provided in Subsections (b)(3) and (b)(4), each fiscal year the City and County of San Francisco shall appropriate \$2.75 per resident of the City and County of San Francisco to the Election Campaign Fund to provide funding for election campaigns as authorized by this Chapter for all

1	candidates for Mayor or the Board of Supervisors who may be eligible to receive such funds.
2	At the request of the Ethics Commission, the Controller shall estimate the number of residents

22	(232) Funds necessary for the Ethics Commission to administer the public
23	financing program for candidates for Mayor or the Board of Supervisors authorized under
24	Section 1.136 of this Chapter shall be taken from the Election Campaign Fund. The

1	Commission's administrative expenses for such public financing program for any election shall
2	not exceed 15% of the total amount of funds in the Election Campaign Fund for that election.

- (3) If the Office of Mayor becomes vacant and an election is held to fill the vacancy for the remainder of the term, the City and County of San Francisco shall appropriate additional funds to the Election Campaign Fund in an amount that ensures that at least \$8.00 per resident is available in the Election Campaign Fund for that election and the next regularly scheduled Mayoral election.
- (4) If an office of a member of the Board of Supervisors becomes vacant and an election is held to fill the vacancy for the remainder of the term, the City and County of San Francisco shall appropriate an additional \$0.25 per resident to the Election Campaign Fund for that election. These additional funds shall not be subject to the limit in Subsection (b)(1) of this Section. Any funds appropriated pursuant to this subsection that are not used for the election to fill the vacancy shall be returned to the General Fund.
- (3) If the Office of Mayor becomes vacant and an election is held to fill the vacancy for the remainder of the term, the City and County of San Francisco shall appropriate additional funds to the Election Campaign Fund in an amount that ensures that at least \$8.00 per resident is available in the Election Campaign Fund for that election and the next regularly scheduled Mayoral election.
- (4) If an office of a member of the Board of Supervisors becomes vacant and an election is held to fill the vacancy for the remainder of the term, the City and County of San Francisco shall appropriate an additional \$0.25 per resident to the Election Campaign Fund for that election. These additional funds shall not be subject to the limit in Subsection (b)(1) of this Section. Any funds appropriated pursuant to this subsection that are not used for the election to fill the vacancy shall be returned to the General Fund.
 - (b) INSUFFICIENT FUNDS.

1	(1) No later than August 1 before an election for Mayor, the Executive
2	Director shall notify the Commission and the Board of Supervisors if less than \$5 million exists
3	in the Election Campaign Fund. If \$5 million does not exist in the Election Campaign Fund,
4	the Commission may, in accordance with the fiscal provisions of the Charter, request a
5	supplemental appropriation from the Board of Supervisors and the Mayor to provide additional
6	funding to the Election Campaign Fund so that at least \$5 million, but no more than \$7 million,
7	exists in the fund for the upcoming election.
8	(2) No later than August 1 before an election for the Board of Supervisors,
9	the Executive Director shall notify the Commission and the Board of Supervisors if less than
10	\$4 million exists in the Election Campaign Fund. If \$4 million does not exist in the Election
11	Campaign Fund, the Commission may, in accordance with the fiscal provisions of the Charter,
12	request a supplemental appropriation from the Board of Supervisors and the Mayor to provide
13	additional funding to the Election Campaign Fund so that at least \$4 million, but no more than
14	\$7 million, exists in the fund for the upcoming election.
15	(c) REPORT BY CONTROLLER. At the request of the Ethics Commission, the
16	Controller shall provide a statement of the total amount of funds in the Election Campaign
17	Fund.
18	SEC. 1.140. ELIGIBILITY TO RECEIVE PUBLIC FINANCING.
19	(a) REQUIREMENTS FOR ALL CANDIDATES. To be eligible to receive public
20	financing of campaign expenses under this Chapter, a candidate must:
21	(1) Have filed a statement indicating that he or she intends to participate in
22	the public financing program under Section 1.142 of this Chapter.
23	(2) Agree to the following conditions:
24	(A) The candidate bears the burden of providing that each contribution
25	the candidate relies upon to establish eligibility is a qualifying contribution;

1		(B) The candidate bears the burden of proving that expenditures made
2		with public funds provided under this Chapter comply with Section 1.148 of this Chapter;
3		(C) The candidate will not make any payments to a contractor or
4		vendor in return for the contractor or vendor making a campaign contribution to the candidate
5		or make more than a total of 50 payments, other than the return of a contribution, to
6		contractors or vendor that have made contributions to the candidate;
7		(D) Notwithstanding Sections 1.114 and 1.116, the candidate shall not
8		loan or donate, in total, more than \$5,000 of his or her own money to the campaign;
9		(E) The candidate shall not accept any loans to his or her campaign
10		with the exception of a candidate's loan to his or her own campaign as permitted by this
11 .		Section; and
12	٠.	(F) The candidate shall agree to participate in at least three debates
13		with the candidate's opponents.
14		(3) Have paid any outstanding late fines or penalties, owed to the City by the
15		candidate or any of the candidate's previous campaign committees, which were imposed for
16		violations of this Code or the campaign finance provisions of the California Political Reform
17		Act (Government Code Sections 84100-85704), provided that the Ethics Commission had
1.8		notified the candidate of such fines or penalties by the time of certification.
19		(4) Have filed any outstanding forms, owed to the City by the candidate or
20		any of the candidate's previous campaign committees, which were required to be filed
21		pursuant to this Code or the campaign finance provisions of the Political Reform Act
22		(Government Code Sections 84100-85704), provided that the Ethics Commission had notified
23		the candidate of such outstanding forms by the time of certification.
24		(5) Have no finding by a court or by the Ethics Commission after a hearing
25		on the merits, within the prior five years, that the candidate knowingly, willfully, or intentionally

. 1	violated any Section of this Code of the campaign infance provisions of this Camornia i Ontical
2	Reform Act (Government Code Sections 84100-85704). For purposes of this Section, a plea
3	of nolo contendere constitutes a finding by a court of a willful violation.
4	(b) ADDITIONAL REQUIREMENTS FOR CANDIDATES FOR THE BOARD OF
5	SUPERVISORS. To be eligible to receive public financing of campaign expenses under this
6	Chapter, a candidate for the Board of Supervisors must:
7	(1) Be seeking election to the Board of Supervisors and be eligible to hold
8	the office sought;
9	(2) Have a candidate committee that has received at least \$5,000 10,000 in
.10	qualifying contributions from at least $75\underline{100}$ contributors before the 70th day before the
11	election; or, if the candidate is an incumbent member of the Board of Supervisors, have a candidate
12	committee that has received at least \$15,000 in qualifying contributions from at least 150 contributors
13	before the 70th day before the election;
14	(3) Be opposed by another candidate who has either established eligibility to
15	receive public financing, or whose candidate committee has received contributions or made
16	expenditures which in the aggregate equal or exceed \$5,00010,000; and
17	(4) Agree that his or her candidate committee will not make qualified
18	campaign expenditures that total more than the candidate's Individual Expenditure Ceiling of
19	\$ <i>143,000</i> 2 <i>50,000</i> , or as adjusted under Section 1.143 of this Chapter.
20	(c) ADDITIONAL REQUIREMENTS FOR CANDIDATES FOR MAYOR. To be
21	eligible to receive public financing of campaign expenses under this Chapter, a candidate for
22	Mayor must:
23	(1) Be seeking election to the office of Mayor and be eligible to hold the office
24	sought;

1	(2) Have a candidate committee that has received at least $\$25,00050,000$ in
2	qualifying contributions from at least $\frac{250500}{500}$ contributors by the 70th day before the election,
3	or, if the candidate is the incumbent Mayor, have a candidate committee that has received at least
4	\$75,000 in qualifying contributions from at least 750 contributors by the 70th day before the election;
5	(3) Be opposed by another candidate who has either established eligibility to
6	receive public financing, or whose candidate committee has received contributions or made
7	expenditures that in the aggregate equal or exceed \$50,000; and
8	(4) Agree that his or her candidate committee will not make qualified
9	campaign expenditures that total more than the candidate's Individual Expenditure Ceiling of
10	\$ <i>1,475,000</i> 1,750,000 <u>1,475,000</u> , or as adjusted under Section 1.143 of this Chapter.
11	(d) ADJUSTMENT OF EXPENDITURE LIMITS AND THRESHOLDS. The Ethics
12	Commission is authorized to adjust:
13	(1) The figures in Subsections (b)(4) and (c)(4) to reflect changes in the
14	California Consumer Price Index, provided that such adjustments shall be rounded off to the
15	nearest \$1,000 for candidates for the Board of Supervisors and the nearest \$5,000 for
16	candidates for Mayor;
17	(2) The figure in Subsection (a)(2)(D) of this Section to reflect changes in the
18	California Consumer Price Index, provided that such adjustments shall be rounded off to the
19	nearest \$1,000;
20	(3) The figures in Subsections (b)(2) and (b)(3) of this Section to reflect
21	changes in the California Consumer Price Index, provided that such adjustments shall be
22	rounded off to the nearest \$500;
23	(4) The figures in Subsections (c)(2) and (c)(3) of this Section to reflect
24	changes in the California Consumer Price Index, provided that such adjustments shall be
25	rounded off to the nearest \$5,000; and

1	(5) The maximum amount of a contribution that constitutes a qualifying
2	contribution pursuant to Section 1.104 to reflect changes in the California Consumer Price
3	Index, provided that such adjustments shall be rounded off to the nearest \$10.
4	SEC. 1.143. ADJUSTING INDIVIDUAL EXPENDITURE CEILINGS.
5	This Section shall apply only if the Ethics Commission has certified that at least one
6	candidate for Mayor or the Board of Supervisors is eligible to receive public funds under this
7	Chapter.
8	(a) The Executive Director shall adjust the Individual Expenditure Ceiling of a
9	candidate for Mayor to an amount equal to the sum of the Total Opposition Spending against
10	that candidate and the highest level of the Total Supportive Funds of any other candidate for
11	Mayor if such amount is greater than $\frac{1,475,0001,750,000}{1,475,000}$, provided that the
12	Executive Director may adjust a candidate's Individual Expenditure Ceilings only in
13	increments of \$100,000.
14	(b) The Executive Director shall adjust the Individual Expenditure Ceiling of a
15	candidate for the Board of Supervisors to an amount equal to the sum of the Total Opposition
16	Spending against that candidate and the highest level of the Total Supportive Funds of any
17	other candidate for the same office on the Board of Supervisors if such amount is greater that
18	\$143,000250,000, provided the Executive Director may adjust a candidate's Individual
19	Expenditure Ceiling only in increments of \$10,000.
20	(c) No later than the second business day after a statement is filed pursuant to
21	Section 1.152 (a)(3) or (b)(3) of this Chapter, the Executive Director shall determine whether
22	the communication supports or opposes one or more candidates.
23	Factors the Executive Director shall use to determine whether the communication
24	supports or opposes one or more candidates include the following:

whether the communication clearly identifies one or more candidates;

1	(2) the timing of the communication;
2	(3) the voters targeted by the communication;
3	(4) whether the communication identifies any candidate's position on a public
4	policy issue and urges the reader or viewer to take action, including calling the candidate to
5	support or oppose the candidate's position;
6	(5) whether the position of one or more candidates on a public policy issue
7	has been raised as distinguishing these candidates from others in the campaign, either in the
8	communication itself or in other public communications;
9	(6) whether the communication is part of an ongoing series of substantially
10	similar advocacy communications by the organization on the same issue; and
11	(7) any other factors the Executive Director deems relevant.
12	(d) Within one business day of the date that the Executive Director makes a
13	determination under Subsection (c), either the candidate(s) identified in the communication or
14	any candidate seeking the same City elective office as the candidate identified in the
15	communication may object to the Executive Director's determination. The Executive Director
16	shall respond to any objection within one business day of receiving the objection.
17	(e) Within one business day of the Executive Director's response, either the
18	candidate(s) identified in the communication or any candidate seeking the same City elective
19	office as the candidate identified in the communication may submit to the Executive Director a
20	request that the Ethics Commission review the Executive Director's determination. Within one
21	business day of receiving the request, the Executive Director shall notify each Commissioner
22	of the candidate's request.
23	If within one business day of the Executive Director's notice, two or more members of
24	the Commission inform the Executive Director that they would like to review the determination,
25	the Executive Director shall schedule a meeting of the Commission on a date that occurs

within one week of the Commissioners' requests. If three members of the Commission vote to
overrule the Executive Director's determination, the Commission shall make a final
determination based on the factors set forth above.

(f) If no candidate objects to the Executive Director's determination, if no candidate requests review by the Commission of the Executive Director's determination, if a request is made and two or more members of the Commission do not request to review the determination, or within one week of two members of the Commission requesting to review the Executive Director's determination, at least three members of the Commission do not vote to overrule the Executive Director's determination, the Executive Director's determination shall become final.

The Executive Director shall determine whether to adjust the Individual Expenditure Ceilings of each candidate for Mayor or the Board of Supervisors pursuant to either Subsection (a) or (b) of this Section within one business day of a final determination.

SEC. 1.144. DISBURSEMENT OF PUBLIC FUNDS.

- (a) PAYMENT BY CONTROLLER. Upon certifying that a candidate is eligible to receive public financing under this Chapter, the Executive Director shall forward the certification to the Controller, and the Controller shall disburse payments to the candidate from the Election Campaign Fund in accordance with the certification and this Section.
- (b) TIME OF PAYMENTS. The Controller shall not make any payments under this Chapter to any candidate more than *nine months* 142 days before date of the election. Payments from the Controller shall be disbursed to eligible candidates within two business days of the Controller receiving notification from the Ethics Commission regarding the amount of the disbursement, except that within fifteen calendar days before the election, such payments shall be made within one business day.
 - (c) PAYMENTS FOR ELECTION EXPENSES TO CANDIDATES FOR MAYOR.

22	The Per Candidate Available Disbursement Limit shall be revised upward according to the formula
23	above if and when it is determined that the candidate or candidates in question did not qualify to

13	claim for public funds must include a minimum of \$5,000 of matching contributions; provided					
14	that in the 14 calendar days preceding an election, a claim must include a minimum of \$1,000					
15	of matching contributions. For candidates for the Board of Supervisors, any submission of a					
16	claim for public funds must include a minimum of \$1,000 of matching contributions; provided					
17	that in the 14 calendar days preceding an election, a claim must include a minimum of \$200 of					
18	matching contributions. All claims for public funds must be submitted no later than 5:00 p.m.					
19	on the 30th day following the date of the election.					
20	(gf) DEPOSIT IN CAMPAIGN CONTRIBUTION TRUST ACCOUNT. A candidate					
21	must deposit all payments received from the Election Campaign Fund in his or her candidate					
22	committee's Campaign Contribution Trust Account.

(b) INSUFFICIENT FUNDS.

- Executive Director shall notify the Commission and the Board of Supervisors whether \$8.00 per resident, after subtracting 15% for the administrative expenses provided under section 1.138(b)(2), exists in the Election Campaign Fund. If \$8.00 per resident, plus 15% for administrative expenses, does not exist in the Election Campaign Fund, the Commission may, in accordance with the fiscal provisions of the Charter, request a supplemental appropriation from the Board of Supervisors and the Mayor to provide additional funding to the Election Campaign Fund so that \$8.00 per resident, plus 15% for administrative expenses, exists in the fund for the upcoming election. - (a) CRIMINAL. Any person who knowingly or willfully violates any provision of this Chapter shall be guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not more than \$5,000 for each violation or by imprisonment in the County jail for a period of not more than six months or by both such fine and imprisonment; provided, however, that any willful or knowing failure to report contributions or expenditures done with intent to mislead or deceive or any willful or knowing violation of the provisions of Section 1.114 of this Chapter shall be punishable by a fine of not less than \$5,000 for each violation or three times the amount not reported or the amount received in excess of the amount allowable pursuant to Section 1.114 of this Chapter, or three times the amount expended in excess of the amount allowable pursuant to Section 1.130 or 1.140.5, whichever is greater.
- (b) CIVIL. Any person who intentionally or negligently violates any of the provisions of this Chapter shall be liable in a civil action brought by the civil prosecutor for an amount up to \$5,000 for each violation or three times the amount not reported or the amount received in excess of the amount allowable pursuant to Section 1.114 or three times the amount expended in excess of the amount allowable pursuant to Section 1.130 or 1.140.5, whichever is greater.
- (c) ADMINISTRATIVE. Any person who intentionally or negligently violates any of the provisions of this Chapter shall be liable in an administrative proceeding before the Ethics Commission held pursuant to the Charter for any penalties authorized therein.

(d) LATE FILING FEES

(1) Fees for Late Paper Filings. In addition to any other penalty, any person who files a paper copy of any statement or report after the deadline imposed by this Chapter shall be liable in the amount of ten dollars (\$10) per day after the deadline until the statement is filed.

(2)	In addition to any other penalty, any person who files an electronic copy			
of a statement or report after the deadline imposed by this Chapter shall be liable in the				
amount of twenty-five dollars (\$25) per day after the deadline until the electronic copy or				
report is filed.				

- (3) Limitation on Liability. Liability imposed by Subsection (d)(1) shall not exceed the cumulative amount stated in the late statement or report, or one hundred dollars (\$100), whichever is greater. Liability imposed by Subsection (d)(2) shall not exceed the cumulative amount stated in the late statement or report, or two hundred fifty dollars (\$250), whichever is greater.
- (4) Reduction or Waiver. The Ethics Commission may reduce or waive a fee imposed by this subsection if the Commission determines that the late filing was not willful and that enforcement will not further the purposes of this Chapter.
- (e) MISUSE OF PUBLIC FUNDS. Any person who willfully or knowingly uses public funds, paid pursuant to this Chapter, for any purpose other than the purposes authorized by this Chapter shall be subject to the penalties provided in this Section.
- (f) PROVISION OF FALSE OR MISLEADING INFORMATION TO THE ETHICS COMMISSION; WITHHOLDING OF INFORMATION. Any person who knowingly or willfully furnishes false or fraudulent evidence, documents, or information to the Ethics Commission under this Chapter, or misrepresents any material fact, or conceals any evidence, documents, or information, or fails to furnish to the Ethics Commission any records, documents, or other information required to be provided under this Chapter shall be subject to the penalties provided in this Section.
- (g) PERSONAL LIABILITY. Candidates and treasurers are responsible for complying with this Chapter and may be held personally liable for violations by their committees. Nothing in this Chapter shall operate to limit the candidate's liability for, nor the

- candidate's ability to pay, any fines or other payments imposed pursuant to administrative or judicial proceedings.
- (h) JOINT AND SEVERAL LIABILITY. If two or more persons are responsible for any violation of this Chapter, they shall be jointly and severally liable.
 - (i) EFFECT OF VIOLATION ON OUTCOME OF ELECTION CANDIDACY.
- (1) If a candidate is convicted, *in a court of law*, of a violation of this Chapter at any time prior to his or her election, his or her candidacy shall be terminated immediately and he or she shall be no longer eligible for election, unless the court at the time of sentencing specifically determines that this provision shall not be applicable. No person convicted of a misdemeanor under this Chapter after his or her election shall be a candidate for any other City elective office for a period of five years following the date of the conviction unless the court shall at the time of sentencing specifically determine that this provision shall not be applicable.
- (2) If a candidate for *Mayor or* the Board of Supervisors *certified as eligible for public financing* is found by a court to have exceeded the Individual Expenditure Ceiling in this Chapter by ten percent or more at any time prior to his or her election, *such violation shall constitute official misconduct.* he or she is ineligible for election, unless the court specifically determines that this provision shall not be applicable. If feasible, the candidate's name shall be removed from the ballot. No candidate for Mayor or the Board of Supervisors who is found by a court to have exceeded the Individual Expenditure Ceiling in this Chapter by ten percent or more after his or her election shall be a candidate for any City elective office for a period of five years following the court's determination unless the court specifically determines that this provision shall not be applicable. The Mayor may suspend any member of the Board of Supervisors for such a violation, and seek the removal of Ethics Commission may make a recommendation to the Board of Supervisors that a candidate found by a court to have exceeded the Individual Expenditure Ceiling in this Chapter by
