John St. Croix Executive Director	active during 2009. The Commission will randomly select committees to be audited at its March 8, 2010 meeting.							
	 Staff has determined that it will be able to audit seven recipient committees that were active during the calendar year 2009. The single audit pool includes: all candidates who ran for City elective office in the November 2009 election ballot measure committees active in the November 2009 election; and general purpose recipient committees that were active in 2009. contributions received by these candidates and committees from the date the committees were formed through December 31, 2009. For general purpose committees, the level of financial activity is based on the sum of expenditures made in 2008 and 2009. The reason for including 2008 expenditure data for general purpose committees is that under California Government Code section 90002(c), the period covered by an audit of a general purpose committee is the previous two calendar years.

Staff is currently administering the public financing program for candidates running for the Board of Supervisors in November 2010 and will continue to administer the public financing program through the first part of fiscal year 2010-2011. The mandatory audits of the 2010 publicly financed candidates for the Board of Supervisors will begin in February 2011. In addition, staff will be preparing guides and forms for the public financing program for candidates for Mayor in the November 2011 election. Candidates for the 2011 election may raise qualifying and matching contributions beginning May 2010 and submit applications for public funding beginning February 2011. Given the Commission's estimate that 25 candidates for the Board of Supervisors will qualify to receive public funding, staff has determined it can perform seven randomly selected audits from the 2009 election cycle.
