

[Campaign and Governmental Conduct Code – Amending Campaign Disclaimer and Disclosure Requirements]

Ordinance amending the Campaign and Governmental Conduct Code to simplify and consolidate campaign finance disclaimer and disclosure requirements.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The Campaign and Governmental Conduct Code is hereby amended by revising Sections 1.104, 1.114, 1.134, 1.135, 1.143, 1.152, 1.160.5, 1.161, 1.161.5, 1.162, and 1.163, to read as follows:

SEC. 1.104. DEFINITIONS.

Whenever in this Chapter the following words or phrases are used, they shall mean:

(a) "Advertisement" shall be defined as set forth in the California Political Reform Act, California Government Code section 81000 et seq. and its enabling regulations, provided that the advertisement supports or opposes one or more City measure or candidates for City elective office.

(ab) "Candidate" shall be defined as set forth in the California Political Reform Act, California Government Code section 81000, et seq., but shall include only candidates for City elective office.

(bc) "Candidate committee" shall mean a committee controlled by a candidate, and primarily formed to support that candidate's election for City elective office.

1 (*ed*) "Charitable organization" shall mean an entity exempt from taxation pursuant to
2 Title 26, Section 501 of the United States Code.

3 (*ee*) "City elective office" shall mean the offices of Mayor, Member of the Board of
4 Supervisors, City Attorney, District Attorney, Treasurer, Sheriff, Assessor, Public Defender,
5 Member of the Board of Education of the San Francisco Unified School District and Member
6 of the Governing Board of the San Francisco Community College District. The Board of
7 Supervisors consists of eleven separate City elective offices, the San Francisco Community
8 College District consists of seven separate City elective offices, and the Board of Education of
9 the San Francisco Unified School District consists of seven separate City elective offices.

10 (*ef*) "Code" shall mean the San Francisco Campaign and Governmental Conduct
11 Code.

12 (*fg*) "Committee" shall be defined as set forth in the California Political Reform Act,
13 California Government Code section 81000, et seq.

14 (*gh*) "Contribution" shall be defined as set forth in the California Political Reform Act,
15 California Government Code section 81000, et seq.; provided, however, that "contribution"
16 shall include loans of any kind or nature.

17 (*hi*) "Controlled committee" shall be defined as set forth in the California Political
18 Reform Act, California Government Code section 81000, et seq.

19 (*j*) "Distributed" shall mean any act that permits a communication to be viewed, read or heard.

20 (*ik*) "Election" shall mean any general, or special municipal election held in the City
21 and County of San Francisco for City elective office or for a local measure, regardless of
22 whether the election is conducted by district or Citywide.

23 (*l*) "Electioneering communication" shall mean any communication, including but not limited
24 to any broadcast, cable, satellite, radio, electronic, or telephone communication, and any mailing,
25 flyer, doorhanger, pamphlet, brochure, card, sign, billboard, facsimile, or printed advertisement, that:

1 (1) refers to a clearly identified candidate for City elective office or a City elective
2 officer who is the subject of a recall election; and

3 (2) is distributed within 90 days prior to an election for the City elective office sought
4 by the candidate or a recall election regarding the City elective officer to 500 or more individuals who
5 are registered to vote or eligible to register to vote in the election or recall election. There shall be a
6 rebuttable presumption that any that any broadcast, cable, satellite, or radio communication and any
7 sign, billboard or printed advertisement is distributed to 500 or more individuals who are eligible to
8 vote for or against the candidate clearly identified in the communication.

9 (3) The term "electioneering communication" shall not include:

10 (A) communications that constitute independent expenditures under this Chapter
11 or expenditures by a candidate committee for the candidate's election;

12 (B) communications made by a slate mailer organization if such
13 communications are required to be disclosed under the California Political Reform Act, California
14 Government Code Section 81000, et seq.;

15 (C) communications paid for by the City or any other local, State or Federal
16 government agency;

17 (D) non-recorded communications between two or more individuals in direct
18 conversation unless such communications are made by telephone and at least one of the individuals is
19 compensated for the purposes of making the telephone communication;

20 (E) communications that appear on bumper stickers, pins, stickers, hat bands,
21 badges, ribbons and other similar memorabilia;

22 (F) news stories, commentaries or editorials distributed through any newspaper,
23 radio station, television station, or other recognized news medium unless such news medium is owned
24 or controlled by any political party, political committee or candidate;

25 (G) member communications;

1 (H) communications that occur during a candidate debate or forum; and
2 (I) communications made solely to promote a candidate debate or forum made
3 by or on behalf of the person sponsoring the debate or forum, provided that such communications do
4 not otherwise discuss the positions or experience of a candidate for City elective office or a City
5 elective officer who is the subject of a recall election.

6 (jm) "Enforcement authority" shall mean the District Attorney for criminal enforcement,
7 the City Attorney for civil enforcement, and the Ethics Commission for administrative
8 enforcement. Nothing in this Chapter shall be construed as limiting the authority of any law
9 enforcement agency or prosecuting attorney to enforce the provisions of this Chapter under
10 any circumstances where such law enforcement agency or prosecuting attorney otherwise
11 has lawful authority to do so.

12 (kn) "Ethics Commission" shall mean the San Francisco Ethics Commission.

13 (lo) "Executive Director" shall mean the Executive Director of the Ethics Commission,
14 or the Executive Director's designee.

15 (mp) "General purpose committee" shall be defined as set forth in the California
16 Political Reform Act, California Government Code section 81000 et seq.

17 (nq) "Independent expenditure" shall be defined as set forth in the California Political
18 Reform Act, California Government Code section 81000 et seq. An expenditure is not
19 considered independent and shall be treated as a contribution from the person making the
20 expenditure to the candidate on whose behalf or for whose benefit the expenditure is made, if
21 the expenditure is made at the request, suggestion, or direction of, or in cooperation,
22 consultation, concert or coordination with, the candidate on whose behalf, or for whose
23 benefit, the expenditure is made.

1 (er) "Individual Expenditure Ceiling" shall mean the expenditure ceiling established for
2 each individual candidate for Mayor or the Board of Supervisors whom the Ethics Commission
3 has certified as eligible to receive public funds under this Chapter.

4 (ps) "Itemized disclosure statement" shall mean a form promulgated by the Ethics
5 Commission that provides a detailed description of the separate costs associated with a
6 communication, including but not limited to photography, design, production, printing,
7 distribution, and postage.

8 (qu) "Mass mailing" shall be defined as set forth in the California Political Reform Act,
9 California Government Code section 81000 et seq., provided that the mass mailing advocates
10 for or against one or more candidates for City elective office.

11 (rv) "Matching contribution" shall mean a contribution up to \$500, made by an
12 individual, other than the candidate, who is a resident of San Francisco. Matching
13 contributions shall not include loans, contributions received more than 18 months before the
14 date of the election, qualifying contributions or contributions made by the candidate's spouse,
15 registered domestic partner or dependent child. Matching contributions must also comply with
16 all requirements of this Chapter. Matching contributions under \$100 that are not made by
17 written instrument must be accompanied by written documentation sufficient to establish the
18 contributor's name and address. The Ethics Commission shall set forth, by regulation, the
19 types of documents sufficient to establish a contributor's name and address for the purpose of
20 this subsection.

21 (sw) "Measure" shall mean any City, San Francisco Unified School District or San
22 Francisco Community College District referendum, recall or ballot proposition, whether or not
23 it qualifies for the ballot.

24 (tx) "Member communication" shall ~~mean a communication made by an organization or its~~
25 ~~committee for the publication, dissemination or communication to the organization's members,~~

1 ~~employees or shareholders, or to the families of the organization's members, employees or~~
2 ~~shareholders by newsletter, letter, flyer, e-mail or similar written or spoken material, that supports or~~
3 ~~opposes a candidate or measure shall be defined as set forth in the California Political Reform Act,~~
4 California Government Code section 81000 et seq. and its enabling regulations, provided that the
5 communication advocates for or against one or more City measures or candidates for City elective
6 office.

7 (b) "Person" shall mean any individual, partnership, corporation, association, firm,
8 committee, club or other organization or group of persons, however organized.

9 (c) "Qualified campaign expenditure" for candidates shall mean all of the following:

10 (1) Any expenditure made by a candidate, or by a committee controlled by the
11 candidate, for the purpose of influencing or attempting to influence the actions of the voters for
12 the election of the candidate to City elective office.

13 (2) A nonmonetary contribution provided to the candidate, officeholder or
14 committee controlled by the candidate.

15 (3) The total cost actually paid or incurred by the candidate or controlled
16 committee of the candidate for a slate mailing or other campaign literature produced or
17 authorized by more than one candidate.

18 (4) Expenses incurred, but for which payment has not yet been made.

19 (5) Expenses associated with complying with applicable laws, including but not
20 limited to the California Political Reform Act, California Government Code Section 81000, et
21 seq., and the provisions of this Chapter.

22 (6) "Qualified campaign expenditure" shall not include filing fees, expenses
23 incurred in connection with an administrative or judicial proceeding, payments for
24 administrative, civil or criminal fines, including late filing fees, costs incurred after the election
25 that do not directly affect the outcome of the election, including but not limited to utility bills,

1 expenses associated with an audit, and expenses related to preparing post-election campaign
2 finance disclosure reports as required by the California Political Reform Act, California
3 Government Code Section 81000, et seq., and the provisions of this Chapter, or for inaugural
4 activities or officeholder expenses.

5 (~~wa~~) "Qualifying contribution" shall mean a contribution of not less than \$10 and not
6 more than \$100 that is made by an individual who is a resident of San Francisco and that
7 complies with all requirements of this Chapter. Qualifying contributions shall not include
8 loans, contributions received more than 18 months before the date of the election or
9 contributions made by the candidate or the candidate's spouse, registered domestic partner or
10 dependent child. Qualifying contributions under \$100 that are not made by written instrument
11 must be accompanied by written documentation sufficient to establish the contributor's name
12 and address. The Ethics Commission shall set forth, by regulation, the types of documents
13 sufficient to establish a contributor's name and address for the purpose of this subsection.

14 (~~bb~~) "Recorded telephone message" shall mean a recorded audio message that
15 expressly supports or opposes a candidate for City elective office that is distributed by
16 telephone.

17 (*cc*) "Refers to a clearly identified candidate for City elective office or a City elective officer
18 who is the subject of a recall election" shall mean any communication that contains the candidate's or
19 officer's name, nickname or image or makes any other unambiguous reference to the candidate or
20 officer such as "your Supervisor" or "the incumbent."

21 (~~dd~~) "Surplus funds" shall mean funds remaining in a candidate's campaign account
22 at the time the candidate leaves City elective office, or at the end of the post-election reporting
23 period following the defeat of the candidate for City elective office, whichever occurs last, and
24 funds remaining in the campaign account of a committee primarily formed to support or
25

1 oppose a measure at the end of the post-election reporting period following the election at
2 which the measure appeared on the ballot.

3 (~~zee~~) "Total Opposition Spending" shall mean the sum of any expenditures made or
4 expenses incurred by any person or persons for the purpose of making independent
5 expenditures, electioneering communications or member communications in opposition to a
6 specific candidate for Mayor or the Board of Supervisors.

7 (~~aff~~) "Total Supportive Funds" shall mean the sum of all contributions received by a
8 candidate committee supporting a candidate for Mayor or the Board of Supervisors, other than
9 any funds in the candidate's Campaign Contingency Account exceeding the candidate
10 committee's Trust Account Limit, plus the expenditures made or expenses incurred by any
11 person or persons for the purpose of making independent expenditures, electioneering
12 communications or member communications in support of that same candidate.

13 (~~gg~~) "Trust Account Limit" shall mean the amount of funds in the Campaign
14 Contribution Trust Account of a candidate committee supporting a candidate for Mayor or the
15 Board of Supervisors whom the Ethics Commission has certified as eligible to receive public
16 funds under this Chapter such that the expenditure of this amount would cause the candidate
17 to reach, but not exceed, the candidate's Individual Expenditure Ceiling. The Trust Account
18 Limit shall be reduced as the candidate spends money and shall be increased when his or her
19 Individual Expenditure Ceiling increases.

20 (~~hh~~) "Unexpended public funds" shall mean all funds remaining in the candidate
21 committee's account on the 30th day after the candidate controlling the committee is either
22 elected or not elected to office, regardless of the source of the funds, but shall not exceed the
23 amount of public funds provided to the candidate. Funds raised after this date are not
24 unexpended funds.

25 (~~ii~~) "Voter" shall mean an individual registered to vote in San Francisco.

1 (~~eejj~~) "Withdrawal" or "withdraw" shall mean, prior to an election, ending one's
2 candidacy or failing to qualify for an office for which a candidate has solicited or accepted
3 contributions.

4 (~~ffkk~~) "Written instrument" shall mean a check, credit card receipt, or record of
5 electronic transfer of funds.

6 SEC. 1.114. CONTRIBUTION LIMITS.

7 (a) LIMITS ON CONTRIBUTIONS TO CANDIDATES. No person other than a candidate
8 shall make, and no campaign treasurer for a candidate committee shall solicit or accept, any
9 contribution which will cause the total amount contributed by such person to such candidate committee
10 in an election to exceed \$500.

11 ~~(1) Per Candidate Limit. No person other than a candidate shall make, and no~~
12 ~~campaign treasurer for a candidate committee shall solicit or accept, any contribution which will cause~~
13 ~~the total amount contributed by such person to such candidate committee in an election to exceed \$500.~~

14 ~~(2) Overall Limit. No person shall make any contribution which will cause the total~~
15 ~~amount contributed by such person to all candidate committees in an election to exceed \$500 multiplied~~
16 ~~by the number of City elective offices to be voted on at that election.~~

17 (b) LIMITS ON CONTRIBUTIONS FROM CORPORATIONS. No corporation
18 organized pursuant to the laws of the State of California, the United States, or any other state,
19 territory, or foreign country, whether for profit or not, shall make a contribution to a candidate
20 committee, provided that nothing in this subsection shall prohibit such a corporation from
21 establishing, administering, and soliciting contributions to a separate segregated fund to be
22 utilized for political purposes by the corporation, provided that the separate segregated fund
23 complies with the requirements of Federal law including Sections 432(e) and 441b of Title 2 of
24 the United States Code and any subsequent amendments to those Sections.

25 ~~(c) LIMITS ON CONTRIBUTIONS TO COMMITTEES.~~

1 ~~(1) Per Committee Limit. No person shall make, and no committee treasurer shall~~
2 ~~solicit or accept, any contribution which will cause the total amount contributed by such person to the~~
3 ~~committee to exceed \$500 per calendar year.~~

4 ~~(2) Overall Limit. No person shall make, and no committee treasurer shall solicit or~~
5 ~~accept, any contribution which will cause the total amount contributed by such person to all~~
6 ~~committees to exceed \$3,000 per calendar year.~~

7 ~~(3) Definitions. For purposes of this Subsection, "committee" shall mean any committee~~
8 ~~making expenditures to support or oppose a candidate, but shall not include candidate committees.~~

9 ~~(d)~~ AGGREGATION OF AFFILIATED ENTITY CONTRIBUTIONS.

10 (1) General Rule. For purposes of the contribution limits imposed by this
11 Section and Section 1.120 the contributions of an entity whose contributions are directed and
12 controlled by any individual shall be aggregated with contributions made by that individual and
13 any other entity whose contributions are directed and controlled by the same individual.

14 (2) Multiple Entity Contributions Controlled by the Same Persons. If two or
15 more entities make contributions that are directed and controlled by a majority of the same
16 persons, the contributions of those entities shall be aggregated.

17 (3) Majority-Owned Entities. Contributions made by entities that are majority-
18 owned by any person shall be aggregated with the contributions of the majority owner and all
19 other entities majority-owned by that person, unless those entities act independently in their
20 decisions to make contributions.

21 (4) Definition. For purposes of this Section, the term "entity" means any person
22 other than an individual and "majority-owned" means a direct or indirect ownership of more
23 than 50 percent.

24 ~~(e)~~ CONTRIBUTOR INFORMATION REQUIRED. If the cumulative amount of
25 contributions received from a contributor is \$100 or more, the committee shall not deposit any

1 contribution that causes the total amount contributed by a person to equal or exceed \$100
2 unless the committee has the following information: the contributor's full name; the
3 contributor's street address; the contributor's occupation; and the name of the contributor's
4 employer or, if the contributor is self-employed, the name of the contributor's business. A
5 committee will be deemed not to have had the required contributor information at the time the
6 contribution was deposited if the required contributor information is not reported on the first
7 campaign statement on which the contribution is required to be reported.

8 (fe) FORFEITURE OF UNLAWFUL CONTRIBUTIONS. In addition to any other
9 penalty, each committee that receives a contribution which exceeds the limits imposed by this
10 Section or which does not comply with the requirements of this Section shall pay promptly the
11 amount received or deposited in excess of the amount permitted by this Section to the City
12 and County of San Francisco and deliver the payment to the Ethics Commission for deposit in
13 the General Fund of the City and County; provided that the Ethics Commission may provide
14 for the waiver or reduction of the forfeiture.

15 (gf) RECEIPT OF CONTRIBUTIONS. A contribution to a candidate committee or
16 committee making expenditures to support or oppose a candidate shall not be considered
17 received if it is not cashed, negotiated, or deposited and in addition it is returned to the donor
18 before the closing date of the campaign statement on which the contribution would otherwise
19 be reported, except that a contribution to a candidate committee or committee making
20 expenditures to support or oppose a candidate made before an election at which the
21 candidate is to be voted on but after the closing date of the last campaign statement required
22 to be filed before the election shall not be considered to be deemed received if it is not
23 cashed, negotiated or deposited and is returned to the contributor within 48 hours of receipt.
24 For all committees not addressed by this Section, the determination of when contributions are
25

1 considered to be received shall be made in accordance with the California Political Reform
2 Act, California Government Code Section 81000, et seq.

3 SEC. 1.134. LIFTING OF VOLUNTARY EXPENDITURE CEILINGS;
4 SUPPLEMENTAL REPORTING IN ELECTIONS FOR ASSESSOR, PUBLIC DEFENDER,
5 CITY ATTORNEY, DISTRICT ATTORNEY, TREASURER, SHERIFF, THE BOARD OF
6 EDUCATION OF THE SAN FRANCISCO UNIFIED SCHOOL DISTRICT, OR THE
7 GOVERNING BOARD OF THE SAN FRANCISCO COMMUNITY COLLEGE DISTRICT.

8 This Section shall apply only if at least one candidate for the City elective office has
9 accepted the applicable voluntary expenditure ceiling, and the Ethics Commission has not
10 lifted that voluntary expenditure ceiling. This Section applies only to candidates for Assessor,
11 Public Defender, City Attorney, District Attorney, Treasurer, Sheriff, the Board of Education of
12 the San Francisco Unified School District, or the Governing Board of the San Francisco
13 Community College District.

14 (a) The voluntary expenditure ceiling shall no longer be binding on a candidate:

15 (1) If a candidate seeking election to the same City elective office, who has
16 declined to accept the voluntary expenditure ceiling, receives contributions or makes qualified
17 campaign expenditures in excess of 100 percent of the applicable voluntary expenditure
18 ceiling,

19 (2) If a person or persons_ make expenditures or payments, or incur expenses
20 for the purpose of making independent expenditures, electioneering communications or
21 member communications that total more than 100 percent of the applicable voluntary
22 expenditure ceiling, and those expenditures or communications clearly identify a candidate
23 seeking election to the same City elective office, or
24
25

1 (3) If a candidate seeking election to the same City elective office, who has
2 accepted the voluntary expenditure ceiling, makes qualified campaign expenditures in excess
3 of 100 percent of the voluntary expenditure ceiling.

4 (b) Any candidate committee that receives contributions, makes qualified campaign
5 expenditures, incurs expenses or has funds in its Campaign Contribution Trust Account that
6 total more than 100 percent of the applicable voluntary expenditure ceiling shall, within 24
7 hours of exceeding 100 percent of the applicable voluntary expenditure ceiling, file a
8 statement with the Ethics Commission, on forms to be provided by the Ethics Commission,
9 stating that fact and any additional information required by the Ethics Commission.

10 ~~(c) Any person other than a candidate committee who makes expenditures or payments, or~~
11 ~~incurs expenses for the purpose of distributing independent expenditures, electioneering~~
12 ~~communications or member communications that clearly identify any candidate in an amount that in~~
13 ~~the aggregate equals or exceeds \$5,000 per candidate shall, within 24 hours of reaching or exceeding~~
14 ~~this threshold, file a statement with the Ethics Commission. The statement shall include a legible copy~~
15 ~~of the communication if it is conveyed in writing or an electronic recording if it is conveyed via audio~~
16 ~~or video, disclose the cost of each communication, and provide any additional information required by~~
17 ~~the Ethics Commission.~~

18 ~~Thereafter, until the Ethics Commission lifts the applicable voluntary expenditure ceiling, any~~
19 ~~such person shall file a supplemental statement with the Ethics Commission each time the person makes~~
20 ~~expenditures for the purpose of distributing independent expenditures, electioneering communications~~
21 ~~or member communications that clearly identify any candidate in an amount that in the aggregate~~
22 ~~equals or exceeds an additional \$5,000 per candidate. The supplemental statements shall be filed~~
23 ~~within 24 hours of reaching or exceeding this threshold, and shall include a legible copy of the~~
24 ~~communication if it is conveyed in writing or an electronic recording if it is conveyed via audio or~~
25

1 ~~video, disclose the cost of each communication, and provide any additional information required by the~~
2 ~~Ethics Commission.~~

3 ~~(dc) Within one business day after receiving a notice indicating that the thresholds in~~
4 ~~subsection (a) have been met, the Ethics Commission shall inform every candidate in the same race that~~
5 ~~the expenditure ceiling has been lifted. The Executive Director shall promptly review statements filed~~
6 ~~pursuant to state and local law, including Government Code section 84204 and Sections 1.161, 1.162,~~
7 ~~and 1.163 of this Chapter, to determine whether a communication supports or opposes one or more~~
8 ~~candidates.~~

9 ~~(d) Within one business day after determining that the a threshold listed in subsection (a) has~~
10 ~~been met with respect to an office appearing on the ballot, the Executive Director shall inform every~~
11 ~~candidate for that office that the Ethics Commission has lifted the applicable voluntary expenditure~~
12 ~~ceiling. The Executive Director shall also post a notice on the Ethics Commission's website and send~~
13 ~~written notice by email to any other person who has requested such notice.~~

14 SEC. 1.135. SUPPLEMENTAL PRE-ELECTION STATEMENTS.

15 (a) Supplemental Preelection Statements. In addition to the campaign disclosure
16 requirements imposed by the California Political Reform Act and other provisions of this
17 Chapter, all San Francisco general purpose committees that make contributions or independent
18 expenditures which support or oppose any candidate for City elective office or City measure that total
19 \$500 or more during the period covered by the preelection statement shall file preelection
20 statements before any election held in the City and County of San Francisco at which a
21 candidate for City elective office or City measure is on the ballot, ~~if the committee makes~~
22 ~~contributions or expenditures totaling \$500 or more during the period covered by the preelection~~
23 ~~statement.~~

24 (b) Time for Filing Supplemental Preelection Statements. In even-numbered years,
25 preelection statements required by this Section shall be filed pursuant to the preelection

1 statement filing schedule established by the Fair Political Practices Commission for county
2 general purpose recipient committees. In odd-numbered years, the filing schedule is as
3 follows:

4 (1) For the period ending 45 days before the election, the statement shall be
5 filed no later than 40 days before the election;

6 (2) For the period ending 17 days before the election, the statement shall be
7 filed no later than 12 days before the election.

8 (c) The Ethics Commission may require that these statements be filed electronically.

9 SEC. 1.143. ADJUSTING INDIVIDUAL EXPENDITURE CEILINGS.

10 This Section shall apply only if the Ethics Commission has certified that at least one
11 candidate for Mayor or the Board of Supervisors is eligible to receive public funds under this
12 Chapter.

13 (a) The Executive Director shall adjust the Individual Expenditure Ceiling of a
14 candidate for Mayor to an amount equal to the sum of the Total Opposition Spending against
15 that candidate and the highest level of the Total Supportive Funds of any other candidate for
16 Mayor if such amount is greater than \$1,475,000, provided that the Executive Director may
17 adjust a candidate's Individual Expenditure Ceilings only in increments of \$100,000.

18 (b) The Executive Director shall adjust the Individual Expenditure Ceiling of a

19 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors

22 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment

1 Section 4. Severability. If any section, subsection, sentence, clause, phrase, or word
2 of this ordinance, or any application thereof to any person or circumstance, is held to be
3 invalid or unconstitutional by a decision of a court of competent jurisdiction, such decision
4 shall not affect the validity of the remaining portions or applications of the ordinance. The
5 Board of Supervisors hereby declares that it would have passed this ordinance and each and
6 every section, subsection, sentence, clause, phrase, and word not declared invalid or
7 unconstitutional without regard to whether any other portion of this ordinance or application
8 thereof would be subsequently declared invalid or unconstitutional.
