Dear Ms. Canny,

Please be advised that the SFPD and the City Attorney's Office have each received at least one Immediate Disclosure Request for the video.

Under Section 67.25 of the Sunshine Ordinance, we are bound to satisfy these requests no later than the close of business Wednesday May 16. As you know, the City Attorney's position is that the video is a court record and therefore a public record. Accordingly, at this time we see no legal basis for the City to withhold the video from disclosure.

Therefore, if you are going to file a writ and request for immediate stay on behalf of your client, you should do so tomorrow and supply us with copies well before close of business (5pm), so that our office can evaluate these agencies' responsibilities under the Sunshine Ordinance in light of any filing.
