Pursuant to subpoena, the Mayor received telephone records from AT&T for Ross Mirkarimi's cell phone and Eliana Lopez's cell phone for the period December 31, 2011 through January 13, 20122. Those AT&T records were limited to certain telephone numbers authorized by the Court, in that they included only communications between Sheriff Mirkarimi's and Ms. Lopez's AT&T cell phone numbers, as well as their communications with telephone numbers associated with Linnette Peralta Haynes (cell phone), Ivory Madison (cell phone), Abraham Mertens (cell phone), the Madison/Mertens landline, and Callie Williams (cell phone). The records included the time and length of telephone calls. The records also included information that a text message was sent or received, but not the content of any text messages.

AT&T provided these records in electronic form (Excel) with a custodian of records declaration and a sheet explaining the codes used by AT&T in its records. We plan to submit these records in the form of a single combined Excel spreadsheet in chronological order, with telephone numbers redacted and names substituted for telephone numbers, and the terms "text message" and "phone call" for the codes used by AT&T.
