### About the Board of Directors:

The Treasure Island Development Authority (TIDA) Board of Directors is the seven-member governing body overseeing the redevelopment of Treasure Island. The Authority Board makes policy decisions critical to the future of Treasure Island, approves large contracts, approves TIDA's annual budget, and acts as both the redevelopment agency and the trustee of the Tideland Trust for Treasure Island. All seven members are appointed by the Mayor, with certain seats approved by the City's Board of Supervisors. The member of the San Francisco Board of Supervisors who represents Supervisorial District 6, in which Treasure Island and Yerba Buena Island are located, sits as an ex-officio, non-voting member of the TIDA Board.

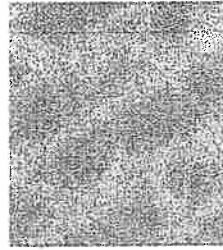

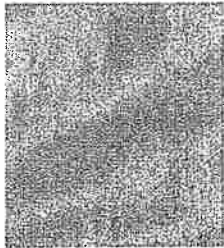
