
### **ARLINGTON HOTEL**

The applicant and owner of the development is Mercy Housing XL, a California limited partnership. The general partner is Mercy Housing Calwest, a California nonprofit public benefit corporation. Mercy Housing California, a California nonprofit public benefit corporation, is the sole member of Mercy Housing Calwest.


The initial limited partner is South of Market Mercy Housing, a California nonprofit public benefit corporation. This entity will be replaced by a tax credit investor if one is identified. Otherwise, the existing limited partnership will remain intact and apply for tax credit exchange funds through the American Recovery and Reinvestment Act.

The developer for the Arlington Hotel is Mercy Housing California. The management company is Mercy Services Corporation.
