The ordinance authorizes the waiver of certain contracting requirements for potential amendments to the contract for certain improvements to Port property at Piers 27-29, including demolition work at Piers 27-29, site grading, substructure repairs and storm water drainage improvements; public access improvements at Piers 19 and 23, to satisfy regulatory permit requirements; removal of pier 1/2 and the remnant of 64, including construction of a new Caspian Tern nesting platform, to satisfy regulatory requirements, and either conduct site improvements to Piers 30-32, including repairs to the marginal wharf, improvements to the Pier 32 deck, pile repairs and utilities or reimbursing the 34<sup>th</sup> America's Cub Event Authority for costs it incurs to conduct this work.
