Comments: Contract is two-year maintenance agreement with two options to extend the term for a period of two years at the City's sole discretion. The option for the first two year period (1/1/15 to 12/31/16) is \$212,772. The option for the second two year renewal period (1/1/17 to 12/31/18) is \$225,969.
