Comments: The original contract was approved by Mayor Diane Feinstein in 1981 in the amount of \$2,302,070. Each year the contract is amended to increase it by the amount of operating subsidy that is needed for the following year. With this amendment, the contract amount will increase by \$118,297 for FY13-14 to \$4,515,711. The term of the contract is 37 years and will expire in 2018.
