Describe the nature of the contract that was approved: Amendment No.4 to New Irvington Tunnel Contract No. CS-820, adds \$500,000 and one year for URS to provide additional design engineer-of-record services for value engineering by the construction contractor for modifications to Alameda West Portal, services for closeout of the project, and additional support services for the inspection of the existing Irvington Tunnel.	
Comments: This contract was originally awarded to URS on May 24, 2005 in the amount of \$8,600,000 and seven year term by the Commission for New Irvington Tunnel seismic design. Three prior amendments were issued between August 2008 and July 2011 increasing the contract by \$5,773,561 and two years for the final design, engineering support for the EIR and support for construction, start-up and commissioning, to address unanticipated increase in reviews of submittals and engineering substitutions/re-designs submitted by the contractor.
