Programmatic Highlights

Between July 14, 2018 and September 14, 2018, the Commission received 22 new complaints, and the Executive Director determined that seven complaints merited dismissal because Staff found no basis to believe a violation of the law within the Commission's jurisdiction had occurred. Also during that time period, the Enforcement & Legal Affairs division opened five new investigations.

In total and as of September 14, 2018, 87 complaints remain in preliminary review, while 85 are under open investigation. The average age of matters in preliminary review is 3.5 months; 95 percent of those comprise complaints received within the last six months, and more than 50 percent comprise complaints received within the last three months. The average age of matters under open investigation is now just over 13 months.

Public Records Requests

The Enforcement & Legal Affairs division assumes primary responsibility for overseeing the Ethics Commission's transparency obligations under the San Francisco Sunshine Ordinance and the California Public Records Act.

In the last six months, the Commission has received and fulfilled 32 public records requests under the Sunshine Ordinance and the Public Records Act, including 10 since the Commission's last meeting on July 20, 2018. In that six-month period, the Commission

received an average of more than five requests per month – or more than one per week – the responsive scope of which ranges from no responsive records to approximately 10,000 pages of responsive records. For operational context, these requests have required some 300 Staff hours, averaging more than 12 Staff hours per week. Overall in response to the requests of these last six months, the Commission has produced approximately 20,000 pages of responsive records, and is currently collecting and reviewing approximately 10,000 more. At present, the Commission's Acting Public Information Officer is a Senior Investigator and Legal Analyst who shoulders the majority of the Staff hours. The volume and nature of these requests have required Staff from both the Enforcement & Legal Affairs division and the Electronic Disclosure & Data Analysis division to work with its outside campaign finance filing vendor NetFile to create new mechanisms by which Staff can more easily generate records for such public records requests.

Operational Updates/Investigative Caseload Data

Investigative matters under the jurisdiction of the Ethics Commission merit investigation after the Enforcement Director's preliminary review finds there is reason to believe a violation of law may have occurred. Once the Enforcement Director has made that determination, the Enforcement division forwards the complaint to the City Attorney and District Attorney under San Francisco Charter section C3.699-13(a) and the complaint is converted into an open investigation. Table 1 summarizes the number of pending open investigations within the Ethics Commission's jurisdiction that remained pending as of September 14, 2018 and as compared to the prior reporting period. As noted above, more detailed information about the Commission's enforcement caseload is provided in Attachments 1 and 2.


