	Programmatic Highlights: Staff Training						
	On March 22, 2019, Senior Investigator Jeffrey Zumwalt provided training to the Enforcement Division on interview techniques he learned and implemented during his eleven years of service as a police detective and police officer. Jeff's training conveyed best practices regarding interview goals, interview preparation, structuring the interview, formatting the questions, the use of documents and evidence, and behavioral analysis. His recommendations will improve the ability of our team to elicit relevant information during investigative interviews and to hold productive conversations with witnesses and respondents.						
	On March 28, 2019, the Ethics Commission hosted counterparts from the Fair Political Practices Commission (FPPC) for a training on prohibited financial conflicts of interest. Staff from the Enforcement, Policy, and Engagement & Compliance Divisions attended the session with the FPPC's Assistant Chief Counsel on the statutory and regulatory conflict of interest provisions set forth in Government Code sections 87100 and 1090, which the Campaign and Governmental Conduct Code incorporates. The FPPC's Supervising Special Investigator provided a second session specifically for staff of the Enforcement Division on best practices for investigating financial conflicts of interest. The occasion also provided the Enforcement Division an opportunity to exchange ideas about general enforcement procedures with our counterparts from the State.

The Commission now has 75 matters in preliminary review and 87 matters under investigation. The Enforcement Division received four new complaints since March 11, 2019, and opened six new investigations. Also in the past month the Executive Director dismissed six complaints based on investigators' analysis, and the Commission closed three matters that

#### **Referrals to Bureau of Delinquent Revenues**

Under San Francisco Charter section C3.699-13(c)(i)(3), the Ethics Commission must refer to the Bureau of Delinquent Revenue penalties that the Commission has assessed but which remain unpaid after a specified period of time. The Commission's Fines Collection Officer has prepared Final Warning Letters for approximately two dozen filers who have not yet paid fees the Commission assessed against them for late-filed campaign disclosure statements. The Commission will refer those delinquent fees should the filers not settle their accounts by the deadline the Fines Collection Officer will fix.

Of those several matters already before the Bureau of Delinquent Revenue, Staff have no updates for the Commission at this time.





Matters in Preliminary Review by Type







