



Background

- ✓ ACAO developed in 2018 as a comprehensive ethics ordinance including a series of new public disclosure requirements
- ✓ In partnership with stakeholders and members of the Board of Supervisors
- ✓ The Board and Mayor approved in May 2018
- ✓ Laws became operative in January 2019
- ✓ ETH implemented online filing tools in Summer 2019



Roll-out summary



JUNE 27: All ACAO-related electronic forms and resources deployed and made available on the Ethics Commission's website.


MID-JULY: Notice sent to City Elective Officers, Board and Commission Members, Department Heads announcing the provisions and filing requirements relevant to City officers and departments participating in contracting activities.

JULY 30: ETH Regulations implementing ACAO became operative to help clarify and define applicable laws.

 NOTIFICATION OF SUBMISSION OF PROPOSAL

Form sfec-126f2

City departments must disclose

- the contract number,
- the nature of the contract, and
- names of all contractors and subcontractors listed as part of submitted proposal(s).

Within 30 business days of receipt of a qualifying proposal

A City elective officer who approves a contract valued at \$100,000 or more in a fiscal year must e-file Form SFEC-126f4 with the Ethics Commission within five business days of approval.
