#### **Programmatic Updates**

## **Staff Development**

As part of our regular outreach to counterparts at peer agencies, and in furtherance of an ongoing effort to deepen our capacity and refine our methods, Enforcement Staff met remotely in late August with David Tristan, the Deputy Executive Director of the Los Angeles City Ethics Commission. Tristan has worked in nearly every capacity in his three decades at that Commission and made his enforcement experience and expertise available to Staff. We focused our discussion on best practices for investigating campaign finance cases and shadow lobbying, two areas in which Los Angeles has secured a number of high profile and high penalty enforcement resolutions. Staff have begun to incorporate insights from that discussion and to further modify our own approaches informed by that discussion.

In the last two weeks Staff have also participated in several remote trainings hosted by the Money Laundering and Asset Recovery Section of the U.S. Department of Justice. While focused primarily on federal statutes and investigative methods available to federal agencies, Staff have nevertheless sought to glean additional insights on approaches that might be applied to its investigations in San Francisco. Staff intend to participate in additional trainings that are scheduled for the coming weeks.

Staff continue to identify opportunities for professional development during this period in which on-site conferences and trainings have been suspended.

#### Fixed Penalty/Streamlined Administrative Resolution

On Wednesday, September 9, 2020, staff of the Fair Political Practices Commission (FPPC) will present before the FPPC's Law and Policy Committee proposed amendments to the regulations governing the FPPC's Streamline and Warning Letter Programs. FPPC Staff are recommending changes based on their experience implementing those programs over the course of the last 18 months. Among other changes, FPPC staff are proposing the following:

- 1. To add additional types of violations that may be handled by streamlined resolution.
- 2. To simplify the penalty calculations to increase predictability and efficiency.
- 3. To create a Second Tier of streamlined resolutions where the respondent does not qualify for treatment under the existing Streamline Program but alternative treatment under the Mainline Program is not wholly warranted.
- 4. To increase the Enforcement Division's discretion to exclude from the program violations that caused minimal public harm and for which a Streamline Penalty is not warranted.

Enforcement Staff will observe the meeting and evaluate how the FPPC's experience and proposed amendments might inform the Staff proposal that remains under development.




# Age of Matters in Preliminary Review



Matters in Preliminary Review by Type




# Average Age of Matters in Preliminary Review by Type


