## Summary and Action Requested

This presentation provides an implementation report on the Form 700 E-Filing Expansion Project. It includes an update on the April 1, 2022 annual Form 700 filing deadline and information on how to view the publicly-available disclosure statements and data through the Commission's website. No action is required by the Commission, as this item is for informational purposes only.

## Background

Public officials and employees who make or influence government decisions are required under California law to file a Statement of Economic Interests, or Form 700, to publicly identify the kinds of financial interests that could be affected by their governmental duties. These public disclosure filings serve as a tool to help us detect and avoid potential conflicts of interests and promote public confidence that actions on governmental decisions are made without any regard to personal gain.

Effective January 1, 2022, employees and consultants occupying designated positions identified in Sections 3.1-103(d) and 3.1-108 of [the City's Conflict of Interest Code](#) ("designated filers") are required to file their Form 700 statements in electronic format using the Ethics Commission's NetFile e-filing system, which is the same online system that has been used by department heads, elected officials, and board and commission members to file their statements since 2014. As with filings by City officials, redacted Form 700 filings by the City's designated filers submitted after December 31, 2021, will be available online to the public immediately after they are submitted. The former paper-based filing process was eliminated, making it easier for filers to submit filings online, increase filing efficiency for departments, and improve public access to reportable information once the filer's disclosure statement is submitted.

Annual Statements of Economic Interest (Form 700) filings by City officials and designated filers were due by Friday, April 1, 2022. These Form 700 filings cover the period January 1, 2021 through December 31, 2021. As of the filing deadline, 91 percent of City officials – including 100 percent of City elective officers currently in office with an April 1 filing deadline – submitted their Form 700 filings on time. In addition, over 92 percent of the 4,700+ City employees and consultants – who were required to file electronically beginning this year using the Ethics Commission's online filing system – submitted their Form 700 filings by the April 1 deadline.

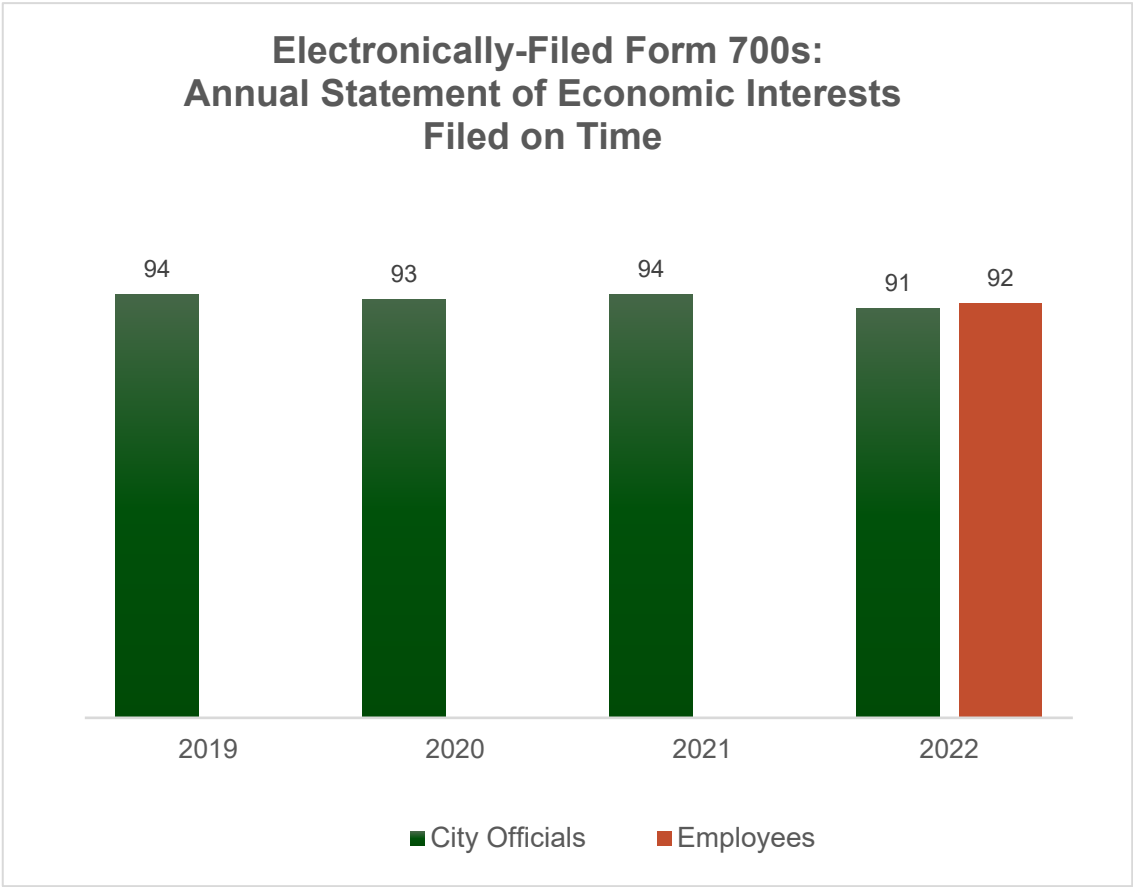

# April 2022 Annual Filing – Overview I

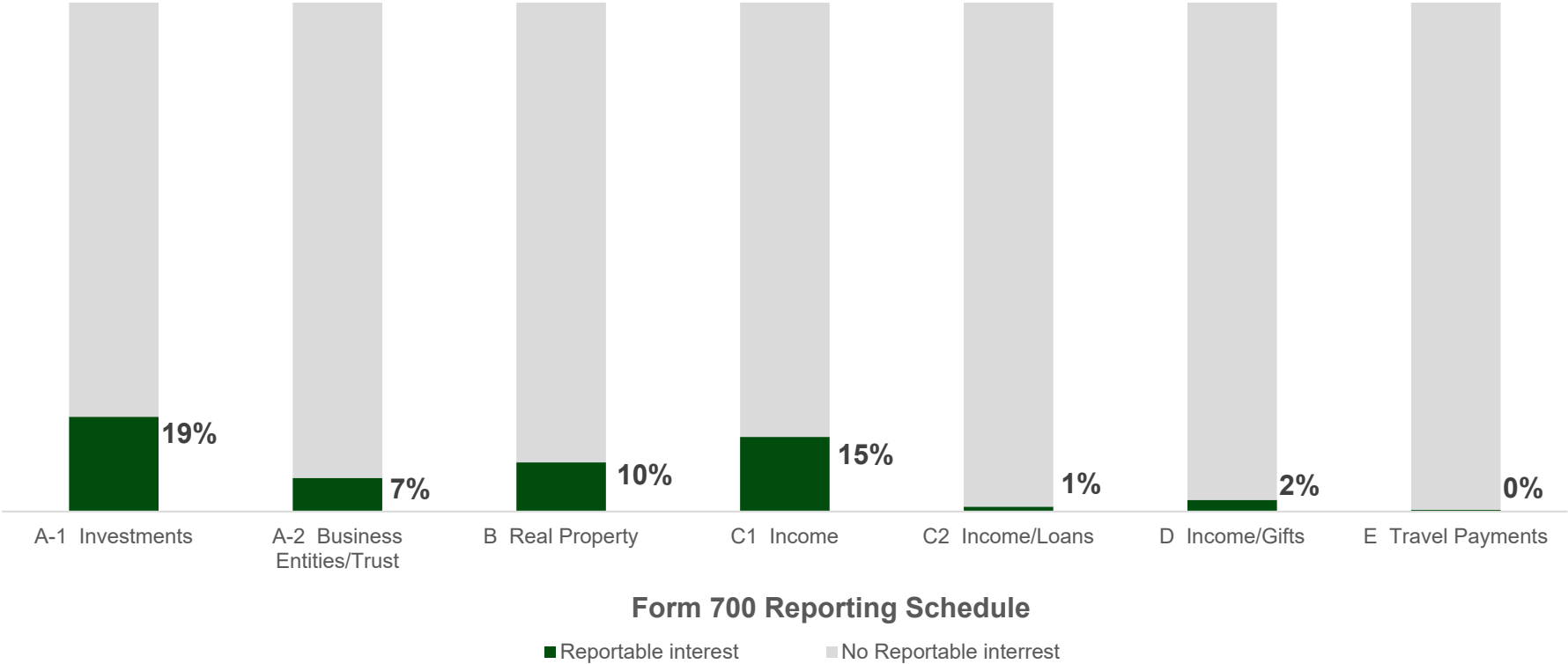


**One-Time Annual Form 700 Filings,

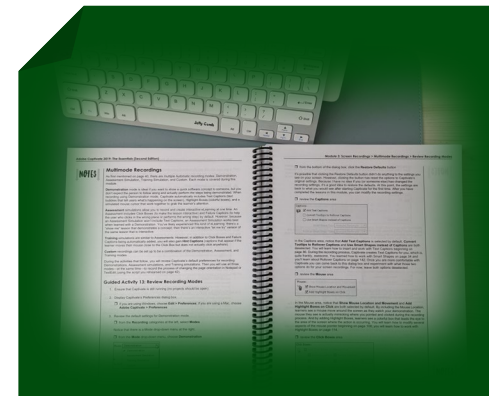

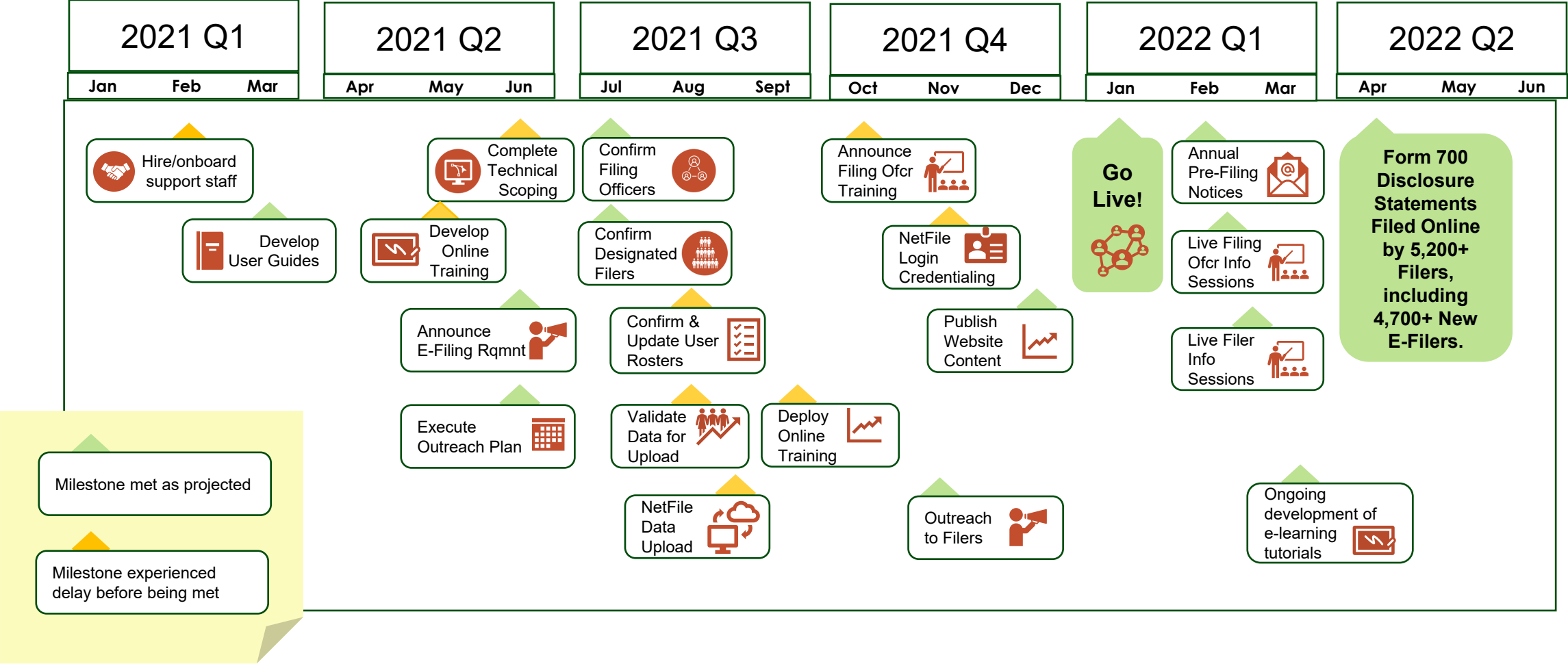

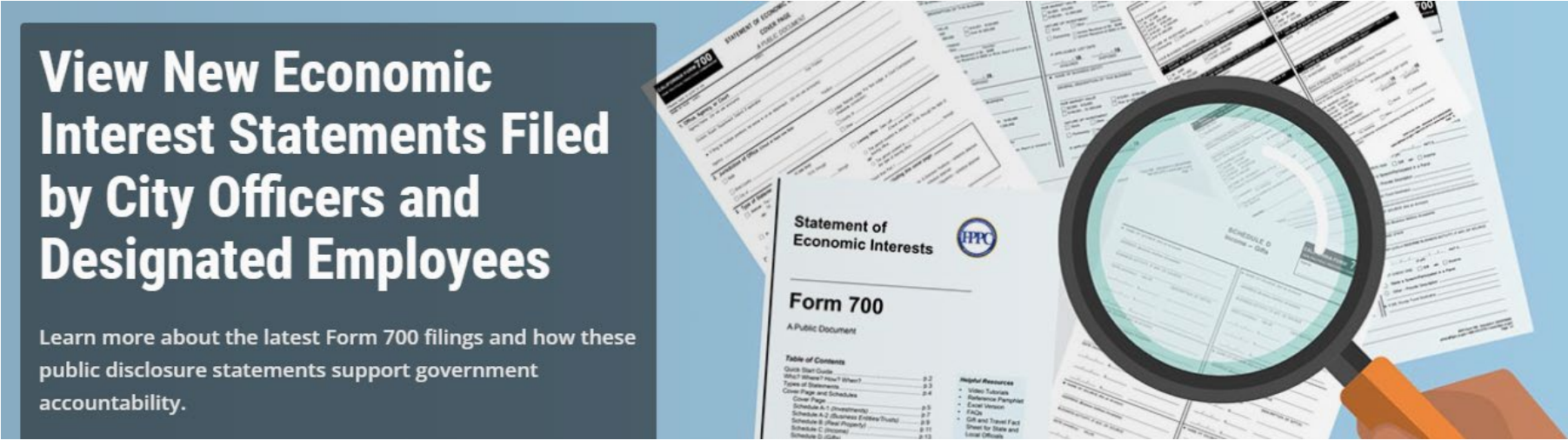

# Search Content Across Filings

## Search and Filter the Contents of Form 700 Statements

Search within the contents across e-filed Form 700 statements to view reportable financial interests such as investments, interests in real property, and income (including gifts and travel payments).

- Find reported data across e-filed statements based on search text, department name, filing year or type of financial interests
- View filtered results on the web page or download to Excel

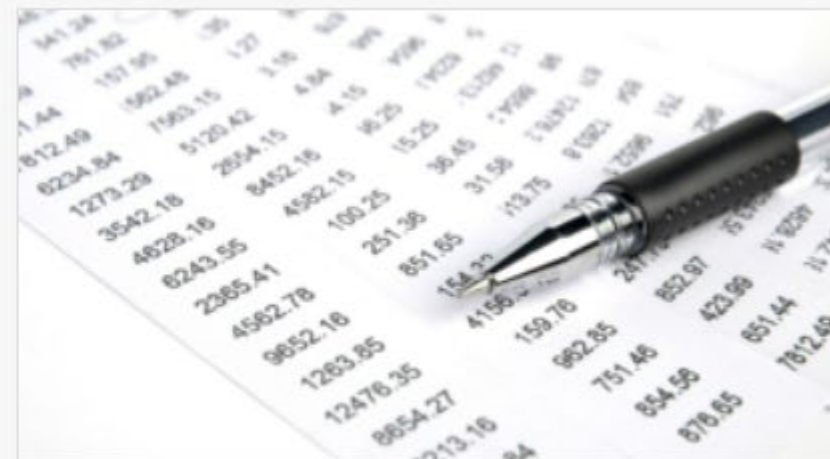
